TERMS AND CONDITIONS OF SCHOLARSHIP PARTICIPATION

The IBA Law Firm Management Committee Leadership Training Programme Scholarship awards a waived registration for a lawyer to attend the <u>virtual Leadership Training Programme</u> to be held from **27 April** to **21 May 2021.**

This scholarship is open to a person who meets the following criteria:

- Applicant must be a fully qualified and practising lawyer who is currently licenced/registered to practice as a lawyer with the relevant professional regulatory body.
- Employees of the IBA, officers of any IBA entity and relatives of any of the aforementioned are excluded from the competition.
- Previous winners of any LPD/SPPI Scholarships are also excluded from the competition. All other applicants may reapply.
- The Applicant does not have to be a member of the IBA or the Law Firm Management Committee.
- The online application form and essay must be completed in English.
 - The one-page essay must outline:
 - 1. yourself and your career;
 - 2. why you feel you should be considered for the Leadership Training Programme Scholarship;
 - 3. what you hope to learn from attending the Leadership Training Programme and how will it help you in your career; and
 - 4. ideas as to how you could help promote the IBA in your country and how you can contribute to future IBA activities.
 - The essay must be original and must be authored by the applicant.
- Each participant may submit only one application.

Applications must be accompanied by an essay in the format specified by the scholarship's directions, as well as a one-page curriculum vitae. You will be prompted to upload the files when completing the application form. The deadline to submit the application is midnight (GMT) **Thursday 25th March**.

TERMS AND CONDITIONS

- 1. Essay must be original, independent, unpublished works. They will not be under consideration for any commercial contract by any publishing house. The author is warranting his or her unrestricted copyright to the essay submitted.
- 2. The decision of the judging committee is final and no correspondence will be entered into.
- 3. The decision will be published on the IBA website. Winners will be contacted at the email address indicated by them on the online application form. The IBA will contact all unsuccessful candidates via his/her email address.
- 4. The IBA is not responsible for the loss, damage or non-arrival of any essay, nor for any costs or expenses incurred in the preparation or the submission of any essay.
- 5. Winning scholars will be requested to write a report on their programme participation and their reports will be circulated to IBA members (through newsletters and posting on the IBA website).
- 6. Participants will be expected to have read and accepted all the above terms and conditions.

- 7. By entering the scholarship all participants consent to all data they submit on this form being shared with the judging panel. The personal data entered on this form will be processed and held in accordance with the **IBA Privacy Policy**.
- 8. The IBA reserves the right to amend and update these terms and conditions at any time without notice.
