The application must be accompanied by a 2,500 word paper in English on the following topic:

What are the legal issues that countries in the Asia-Pacific region will have to reckon with, both within their own borders and regionally, in dealing with the right of access to clean water and sanitation?



Criteria

- 1. The Asia Pacific Regional Forum Scholarship to attend the 7th Asia Pacific Regional Forum Biennial Conference from 22 24 February 2023 is free to enter. It is open to all lawyers up to and including the age of 35, practicing in an Asia Pacific country, whether or not they are members of the IBA.
- 2. Applications should be sent by email or fax to Maria Chew at the IBA office: maria.chew@int-bar.org / +82 2 6279 8100.
- 3. Applications should be written in English and be accompanied by a 2,500 word paper on the following topic: What are the legal issues that countries in the Asia-Pacific region will have to reckon with, both within their own borders and regionally, in dealing with the right of access to clean water and sanitation?
 - Papers must be original, unpublished works. They will not be under consideration for any Commercial Contract by any publishing house. The author is warranting his/her restricted copyright to the paper submitted.
- 4. Applications must be submitted and received by **18 NOVEMBER 2022**. Applications received after this time will not be considered.
- 5. All applications will be submitted to the Scholarship Committee which will consist of IBA Asia Pacific Regional Forum Officers.

 They will judge the papers primarily on the basis of legal argumentation, research, style, logic, originality and overall quality of the content.
- 6. It is planned that the IBA Office will communicate the conference selection panel decision to the successful applicant by **13 DECEMBER 2022.**
- 7. The decision of the judging committee is final and no correspondence will be entered into. The decision will be published on the IBA website. The successful applicants will be contacted at the email address given on the application form.
- 8. The Scholarship Award includes:
 - Free registration for the 7th Asia Pacific Regional Forum Biennial Conference, 22 24 February 2023, Singapore, including social events; and
 - A contribution towards travel and accommodation costs to the conference.

- 11. The IBA or the Scholarship Committee and the organisers of the scholarship are not responsible for the loss, damage or non-arrival, nor for any costs or expenses incurred in the preparation or the submission of your application.
- 12. Please note if you are awarded a scholarship you will be required to confirm your attendance by providing a copy of your travel documents for your flight to be booked and visa letter issued (should you need to apply for one). These documents must be sent to Maria Chew (maria.chew@int-bar.org) by 9 January 2023.
- 13. The IBA has the right to publish a selection of the papers submitted, including but not limited to the winning paper (either the full text or extracts thereof) up to 18 months after the competition has ended; this includes but is not limited to the publication in the conference documentation and/or on the IBA website and/or other IBA publications. In any event, the name of the author will be indicated appropriately. Authors shall include a biographical note giving details of their legal career, studies and professional appointments. Papers received that are not in this form may not be considered.
- 14. If you are awarded a scholarship please note that proficiency in English is mandatory and you will be required to provide evidence that you are able to practise law.
- 15. Participants will be expected to have read and accepted all the above rules.
