1400 – 1500 **Terrorism designations, organised crime, and sanctions convergence: implications for business in Latin America**

This session will examine the legal, regulatory and operational implications of evolving terrorism designations, with a focus on the increasing convergence between anti-money laundering (AML), counter-terrorist financing (CTF) and sanctions regimes, as well as the expansion of 'national security risk' concepts in the context of organised crime. It will explore how these developments affect risk classification and exposure, prompting companies to reassess country, sectoral and counterparty risks in environments where criminal networks may be indirectly linked to sanctioned or high-risk activities. The discussion will also address operational and financial system impacts, including potential spillover effects on banking relationships, access to credit, trade finance, insurance coverage and cross-border transactions driven by heightened risk sensitivity among financial institutions and global partners.

1400 – 1500 **M&A, private equity and compliance integration: from risk mitigation to value creation**

This session will explore how compliance has evolved into a core element of M&A and private equity strategy, shaping outcomes across the entire deal lifecycle. It will address risk-based pre-acquisition due diligence under tight timelines, including the identification and pricing of compliance risks, as well as post-acquisition integration and the challenges of successor liability and effective remediation in line with expectations from authorities such as the US Department of Justice and the Brazilian CGU, among others. The discussion will also highlight how robust compliance frameworks can enhance valuation, support smoother exits and act as a strategic value driver for private equity sponsors and corporate buyers alike.

1500 – 1600 **From isolated alerts to collective intelligence: blockchain, data federation and the privacy-preserving technologies protecting against fraud and corruption**

This session will explore trusted data ecosystems and how emerging technologies are reshaping transparency and transaction security, moving from blockchain and distributed ledgers in a broader shift. Fraud and corruption schemes cross institutional boundaries, yet each organisation still assesses risk seeing only its own data. Panellists will discuss how federated data sharing, anonymisation, pseudonymisation and privacy-enhancing technologies allow institutions and authorities to detect cross-institutional patterns without surrendering data sovereignty, bank secrecy or data protection safeguards. Attendees will gain practical insights into collaborative fraud prevention, regulatory expectations for information sharing arrangements and the governance needed to make shared intelligence explainable, auditable and lawful.
