Russia: Halt suppression of expression by human rights lawyers and defenders

Mr. President,

Lawyers' Rights Watch Canada, the International Bar Association's Human Rights Institute, and Lawyers for Lawyers, and The Law Society of England and Wales with endorsement by OVD-Info, welcome the Special Rapporteur's emphasis on the vital voices of human rights defenders for achieving the Sustainable Development Goals (SDGs).¹

In too many countries, human rights lawyers and defenders are threatened, harassed, attacked, prosecuted, imprisoned, tortured or ill-treated as a result of their legitimate work and expressions upholding human rights.

Russia's war of aggression against Ukraine has disrupted progress towards the SDGs throughout the world.² Russian authorities systematically weaponize laws and courts to repress voices of human rights lawyers, defenders, and civil society, thereby:

- punishing peaceful expression of dissent and anti-war opinions,³
- denying access to information about rights violations,⁴
- suppressing the right of access to effective legal representation,⁵
- subjecting Russian lawyers and defenders to repressive "foreign agent" designations,⁶
- and even prosecuting lawyers for statements made in court while defending clients.⁷

We urge the Council to insist that all States, including Russia:

- halt the illegitimate use of laws to curtail expression;
- ensure the independence of judges and lawyers;
- release all arbitrarily detained lawyers and defenders; and
- withdraw all charges and fines against those engaged in peaceful anti-war expression.
