- Established in 1947, largest international legal organization
- Over 80,000 individual lawyers
- 190 bar associations & law societies
- Active on all continents, over 160 countries
- Principal aims and objectives:
 - To promote an exchange of information between legal associations worldwide;
 - To support the independence of the judiciary and the right of lawyers to practise the profession without interference;
 - Support of human rights for lawyers worldwide through its Human Rights Institute.
