Worldwide trends in extradition law

The panel will discuss the most recent developments in extradition law worldwide, including aspects of international arrest warrants (red notices) via INTERPOL. Our panellists will describe their approaches of defence in extradition cases and the legal background of their jurisdiction.

Regarding extradition cases the panel will pay special attention to:

- Cooperation standards/set-ups between defence counsel in requesting state and requested state
- Extradition of high-profile individuals
- Inappropriate prison conditions in the requesting state as a potential blocking argument

- Actual problems/experiences within the European Union in European Arrest Warrants cases

Furthermore, the misuse of INTERPOL red notices by its members and options for defence counsel will be discussed. Here, the panel will take a closer look at the work of the Commission for the Control of INTERPOL's Files (CCF).

Ill-gotten gains and asset recovery

This session will examine the delicate topic of restitution of ill-gotten assets (or the proceeds of bribery) stashed in foreign jurisdictions to the victim state. We will look into the procedural instruments available in various states to freeze and eventually return assets to the victims of bribery. We will consider civil and criminal proceedings, mutual legal assistance, as well as possibly arbitration. We will also address international treaties in place, show the practical hurdles when it comes to restitution and answer questions such as:

- Who are the victims?
- How to ensure that the new government does not misuse the restituted funds again etc
- What are the interactions of the various proceedings?

TOPIC ONE – How will you dispose of it?

Environmental crimes in transnational context and the impact of the Covid-19 epidemic

According to law enforcement agencies, when we deal with environmental crime, we deal with the fourth largest criminal enterprise in the world. Environmental crime encompasses a broad list of illicit activities, which can cause considerable damage to ecosystems increasing the risk of disease, including environmental disaster, food chain contamination, illegal waste trafficking, water,

land and air pollution or contamination.

International environmental crimes are potentially more difficult for regulatory agencies to address because of issues surrounding jurisdiction, economic competition, and language barriers. Still, it is clear that environmental crime has become an international issue that has evolved as the process of globalisation has unfolded in our society.

The context has been deeply impacted by the Covid-19 pandemic: the massive use of protective/preventive tools (such as face masks or do-it-yourself tests) creates the problem of their disposal and gives an incredible opportunity for illicit business to undertake organised crime.

The panel will address these issues and other topics across several jurisdictions, discussing both defensive strategies and prosecutors' approaches to environmental crime.

TOPIC TWO – #Metoo: Sexual harassment and whistleblower protection in the workplace

Social media and news outlets are filled with stories of female victims of sexual harassment. The wrongs take place in politics, boardrooms, workplaces, sports, and beyond. Some lawmakers address the fight against sexual harassment, and in many countries, sexual harassment is illegal and a form of gender discrimination. Yet, too often, if cases reach the courts, employers and alleged perpetrators are shielded by the existence of an official policy, regardless of whether the policy is effective in addressing the abuse. In many countries, only a small percentage of job discrimination lawsuits are fully litigated. In others, workers who are considered independent contractors lack protections from sexual harassment claims. Moreover, the narrow interpretation by some judges of what constitutes sexual harassment causes numerous dismissals of 'women's well-documented (civil) claims of sexual harassment at work'.

Since 2018, in response to growing concerns over sexual harassment behaviours within the legal profession, the IBA has issued important reports that complement each other – Sextortion: A Crime of Corruption and Sexual Exploitation; Us Too? Bullying and Harassment in the Legal Profession; and Whistleblower Protections: A Guide.

Should sexual harassment be treated as its own crime? Why is it so difficult to link corruption with sexual favours? How would we distinguish between civil sexual harassment and criminal sexual harassment? Should sexual harassment also include psychological abuse and bullying? What constitutes sexual harassment in different countries, who can pursue a claim and how do countries handle the claims? How can whistleblowers be adequately protected from repercussions when reporting sexual harassment

and sextortion? These are some of the many questions that this session will attempt to explore.

'Transparency and open justice' or 'guilty until proven innocent'?

This panel will look at transparency in the court process and answer questions such as:

- Is it an essential component of criminal justice that all court hearings are public?
- That defendants are named at an early stage of proceedings?
- That journalists have access to the case papers?
- Or is justice better served by protecting the identity of the accused and restricting the information available to journalists and the public until trial?

We will look at how questions of transparency and open justice are dealt with in white collar cases, including:

- Whether suspects should be named publicly and at what point (eg, when they become the subject of investigation, when they are charged or later in the process)
- Issues that arise where allegations are made against a person in the context of a court case (eg, as a co-conspirator) but they are not formally charged
- The public interest in knowing about cases (eg, corruption cases) at an early stage versus the use of reporting restrictions to prevent media coverage of cases until trial
- The extent to which the media is able to access information about hearings in advance (including the fact of the hearing and key documents relating to the hearing)
- The challenges posed by Deferred Prosecution Agreements and the impact of this on justice
