Infrastructure/urban planning and regulation/ environmental innovations – a discussion of some of the social, economic, political and regulatory challenges in developing an effective response to the competing mobility options

The internal combustion engine has been the dominant drive system in Europe over the last century and has helped to shape and reconfigure the urban landscape. The coming decades will see a dramatic shift in transportation in the face of competing forms of mobility and increasingly stringent environmental regulations. Massive infrastructure investment will be necessary to take account of the needs of these alternative forms of mobility and to establish integrated transport networks of people and goods. Data and connectivity

This session will shed light on the digital features modern connected vehicles offer and the framework regarding data collection, access and use under data protection and privacy laws. We will be looking at the essential questions of the ownership and protection of relevant data (and type of data) from the perspective of the various stakeholders such as manufacturers, service providers and users. This includes identifying where, when and how data is collected and who can use and access, and for what commercial goals. The EU has provided a draft for a EU Data Act regarding the use of and access to data (e.g. telemetric data) and this session will also discuss how it is expected to affect the approach in the market. Furthermore, we will discuss the ways individuals consent to or reject the collection of data relating to the vehicle, the operator (and other passenger) and when data once collected is to be deleted (privacy by design/default).

Interactive workshop – hot topics in the European automotive and mobility services industry

The session will take the form of a workshop with moderators facilitating round table discussions on some of the legal hot topics in the mobility services industry, including current legislative development, data ownership, opportunities and challenges for autonomous vehicles and more.

- The Road to Autonomous Vehicles – discussing the regulatory framework for autonomous vehicles in Europe including recent legislative developments on the EU and national level.
- Opportunities and challenges with data from autonomous vehicles - contemplating questions about who is the owner and who has right to access the different sorts of data generated from the connected vehicle and whether the current regulatory framework is sufficient for what is coming. The General Counsel perspective

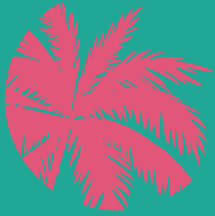

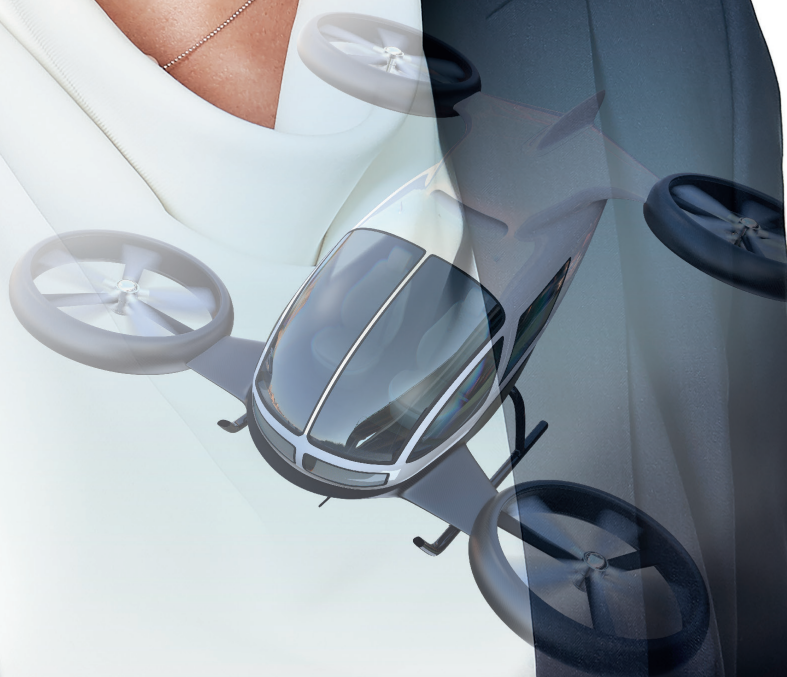
