
As of June 2023,

328 local governments have introduced ordinance or guideline for same-sex partnership recognition and 5,171 couples have registered their relationships

According to the poll in 2023, more than 70% of people in Japan are in favor of same-sex marriage



#### Background

- Negative Attitude of the government
- Same-sex marriage "is an issue that will alter the way we think about family, values, and society." (PM Kishida)
- "I hate even to see them (same-sex couples) and do not want to live next door to them."
- "Allowing same-sex marriage would cause quite a few people to abandon this country." (Then-Executive Secretary to PM Masayoshi Arai)



## "Marriage for All" Lawsuits

February 14, 2019: Lawsuits filed in four district courts: Tokyo, Osaka, Nagoya and Sapporo. September 5, 2019: Lawsuit filed in Fukuoka District Court March 21, 2021: Additional lawsuit filed in Tokyo District Court

In the lawsuits, the plaintiffs claim

① The law that does not recognize same-sex marriage between persons of the same sex violates the Constitution.

**2** It is illegal for the Diet to neglect a law that violates the Constitution.



### Article 24 of the Constitution

#### Paragraph I

Marriage shall be based only on the mutual consent of both sexes and it shall be maintained through mutual cooperation with the equal rights of husband and wife as a basis.

#### • Paragraph 2

With regard to choice of spouse, property rights, inheritance, choice of domicile, divorce and other matters pertaining to marriage and the family, laws shall be enacted from the standpoint of individual dignity and the essential equality of the sexes.



### Article 14 (1) of the Constitution

All of the people are equal under the law and there shall be no discrimination in political, economic or social relations because of race, creed, sex, social status or family origin.

#### Mar. 17, 2021 Sapporo: Landmark "Unconstitutional" Ruling!!

"The fact that the Constitution provides heterosexuals with the opportunity to use the institution of marriage, but does not provide homosexuals with the legal means to enjoy even some of the legal effects of marriage, violates Article 14(1) of the Constitution to the extent described above."

Article 24 of the Constitution need not be interpreted solely in terms of its wording; it is appropriate to interpret it in the context of a clearer recognition of respect for the individual.


It is reasonable to assume that Article 24(1) of the Constitution includes the intention to provide for marriage as a free association between persons, and guarantees not only marriages between "both sexes", that is, opposite -sex couples, but also same-sex couples to the same extent.
