TERMS AND CONDITIONS OF VLOGGING COMPETITION FOR YOUNG LAWYERS

The International Bar Association is running a vlogging competition for young lawyers and law students on the topic of Mental health and wellbeing in the legal profession.

The winner of the YOUNG LAWYER Vlogging Competition, will receive the following:

- two years' free membership of the IBA, with access to all IBA committees, all the committee content and publications, access to member directory for networking, and availability of free member events.

The vlogging competition for young lawyers is open to persons who meet the following criteria:

- Employees of the IBA, officers of any IBA entity and relatives of any of the aforementioned are excluded from the competition.
- 'Young Lawyer' is defined as any lawyer up to and including the age of 35 at the time of the close of the competition (30 September 2021).
- IBA membership is not required in order to submit an application.
- Applicants must either be:
 - a) a fully qualified lawyer who is licenced/registered to practice as a lawyer with the relevant professional regulatory body; or
 - b) undertaking the qualification process (education and/or vocational) to pass the bar (or the equivalent qualification in the relevant jurisdiction) to become fully qualified, providing they hold a temporary or permanent licence to practice as a trainee, or are undertaking a training scheme that is recognised by the professional regulatory body.

Therefore, both newly qualified lawyers and trainees can apply.

- Must have sufficient proficiency in English.
- The online application form and vlog must be completed in English.
- Must be original creator of the vlog.
- Each participant may only submit one entry across both vlogging competitions.

The deadline to submit the application is midnight British Summer Time (BST) on
Thursday 30 September 2021.

TERMS AND CONDITIONS

1. Vlog entry must be original, independent, unpublished work. The author is warranting his or her unrestricted copyright to the vlog submitted.
2. All vlog entries must follow the stipulated specifications (maximum 3 minutes in length) and landscape format. Others will not be accepted and considered.
3. **Any applicant who contacts an IBA Officer regarding the content of their vlog will be automatically disqualified.**
4. The decision of the judging committee is final and no correspondence will be entered into. The decision will be published on the IBA website. Winners will be contacted at the email address indicated by them on the online application form. They will be requested to provide a biographical note giving details of their legal career, studies and professional appointments.
5. The IBA has the right to publish all vlogs submitted, including but not limited to the winning vlog (either in full or extracts thereof) this includes but is not limited to the publication in all relevant IBA conference documentation and/or on the IBA website and/or other IBA publications. In any such event, the name of the author will be indicated appropriately.
6. The IBA, IBA Sections, IBA Committees and organisers of the competition are not responsible for the loss, damage or non-arrival of any entries, nor for any costs or expenses incurred in the preparation or the submission of these.
7. Applicants must have sufficient proficiency in English and evidence that they are eligible to practice law.
8. With the entry to the vlogging competition, all participants agree to the IBA Data Privacy Policy (www.ibanet.org/privacy-policy) and their data and vlogs being shared with the judging panel, for the sole purpose of this competition.
